Approve Resolution 20-33 adopting the Tentative Budget for the West Jordan Fairway Estates Special Service Recreation District for Fiscal Year 2020-2021, and setting June 10, 2019 as the date for a public hearing regarding the final adoption of the budget and supporting property tax rates.

PURPOSE FOR COUNCIL TIME (What specifically is needed from the council, i.e. specific questions to be answered)

Approve Resolution 20-33 adopting the Tentative Budget for the West Jordan Fairway Estates Special Service Recreation District for Fiscal Year 2020-2021, and setting June 10, 2019 as the date for a public hearing regarding the final adoption of the budget and supporting property tax rates.

SUMMARY (Brief synopsis of the of the issue)

The Board formally accepted the Tentative Budget in a regularly schedule public meeting on May 13, 2020. On May 21, 2020, the Board held a work session to review and consider the budget.

Per Utah State Code §10-6-111 3(a), "...a governing body in any regular public hearing or special public hearing shall review, consider, and tentatively adopt each tentative budget; and may, before the public hearing amend or revise each tentative budget."

Per Utah State Code §10-6-112, "Each tentative budget adopted by the governing body and all supporting schedules and data shall be a public record in the office of the city auditor or the city recorder, available for public inspection for a period of at least 10 days prior to the adoption of a final budget, as hereinafter provided."

Per Utah State Code §10-6-114, At the time and place advertised, or at any time and place to which the public hearing may be adjourned, the governing body shall hold a public hearing on the budgets tentatively adopted. All interested persons in attendance shall be given an opportunity to be heard, for

or against, the estimates of revenue and expenditures or any item thereof in the tentative budget of any fund.

State code requires the adoption of the Tentative Budget at least 10 days prior to the adoption of a final budget which must be adopted by June 30, 2020 unless the Board is considering a change to the property tax rate.

**A RESOLUTION ADOPTING THE TENTATIVE BUDGET FOR THE
FISCAL YEAR BEGINNING JULY 1, 2020 AND ENDING JUNE 30, 2021
AND SCHEDULING A HEARING TO RECEIVE PUBLIC COMMENT
BEFORE THE FINAL BUDGET IS ADOPTED.**

WHEREAS, the Board of the West Jordan City Fairway Estates Special Service Recreation District is required to review, consider, and adopt the tentative budget in a regular or special meeting called for that purpose; and

WHEREAS, the tentative budget adopted by the Board and all supporting schedules and data shall be a public record in the City Clerk's Office and on the City website, available for public inspection for a period of at least ten (10) days prior to the adoption of the District's final budget; and

WHEREAS, at the meeting in which the tentative budget is adopted, the Board shall establish the time and place to receive public comment on the budget and shall order that notice thereof be published at least seven (7) days prior to the hearing as required in State law; and

WHEREAS, the purpose of the hearing is to receive public comment before adoption of the final budget.

NOW, THEREFORE, be it resolved by the Board of the West Jordan City Fairway Estates Special Service Recreation District:

SECTION 1. The tentative budget for fiscal year 2020-2021, submitted herewith, is hereby adopted and is ordered to be filed and maintained as a public record, available for public inspection in the City Recorder's Office at West Jordan City Hall located at 8000 South Redwood Road, Third Floor, West Jordan, Utah and the City website at www.westjordan.utah.gov until adoption of the final budget.

SECTION 2. A public hearing to receive comment before the District's final budget is adopted shall be held on Wednesday, June 10, 2020 at approximately 7:00 p.m. in the West Jordan City Council Chambers located at 8000 South Redwood Road, Third Floor, West Jordan, Utah.

SECTION 3. The City Clerk shall publish notice of said public hearing consistent with requirements of Section 10-6-113 of the Utah Code Annotated.

SECTION 4. The budgets for the Funds described above show balanced revenues and expenditures in the following total amounts:
