### 1. AGENDA SUBJECT

Consider approving **Resolution No. 21-019** authorizing unclaimed items from Police Evidence be put to a public interest use, sold, and the proceeds put to a public interest use, or destroyed.

### 2. PURPOSE FOR COUNCIL TIME

To receive authorization to dispose of the property on the attached list and put it, or the proceeds from the sale of such property to the public interest, uses of law enforcement, or the General Fund as the City Administrator or the Mayor deem appropriate.

To receive authorization to destroy any property on the attached list that is unfit for a public interest use or for sale.

### 3. SUMMARY

In the course of regular business, the Police Department takes custody of property that may be needed as evidence. When any such property is no longer needed for evidence, reasonable attempts are made to return it to the owner. If property that is no longer needed as evidence is unclaimed after proper notice and reasonable attempts to contact the owner or cannot otherwise be returned, state law authorizes the City Council to put the property to a public interest use, sell the property and put the proceeds to a public interest use, or destroy the property. Such approval is being sought for the items on the attached list.

### 4. TIME SENSITIVITY / URGENCY

As soon as possible, there are limited times throughout the year auctions for this type of property occur.

### 5. BUDGET IMPACT

No cost to the City is apparent. To the contrary, property no longer needed as evidence or proceeds from its sale, will be put to a public interest use in support of law enforcement or the General Fund.

**6. STAFF RECOMMENDATION**

The Police Department recommends approval of **Resolution No. 21-019** authorizing property no longer needed as evidence to be put to a public interest use, sold, and the proceeds of the sale put to a public interest use, or destroyed if the property cannot be put to a public interest use or sold.

I move the Council adopts **Resolution No. 21-019** authorizing the disposal of property on the attached list and put it, or the proceeds from the sale of such property to the public interest, uses of law enforcement, or the General Fund as the City Administrator or the Mayor deem appropriate. To receive authorization to destroy any property on the attached list that is unfit for a public interest use or sale.

**11. OTHER INFORMATION** *(if applicable)*

When property that is no longer needed as evidence is unclaimed despite proper efforts to locate the rightful owner, the police agency, with the permission of its legislative body, may “(i) apply the property to a public interest use; (ii) sell the property at a public auction and apply the proceeds of the sale to a public interest use; or (iii) destroy the property if the property is unfit for a public interest use or for sale.” Utah Code § 24-3-103(6). If the item of unneeded evidence is a firearm, there are additional requirements regarding who the agency may sell the firearm to. See Utah Code § 24-3-103.5. A “public interest use” means “(a) use by a government agency as determined by the legislative body of the agency’s jurisdiction; or (b) donation of the property to a nonprofit charity registered with the state.” Utah Code § 24-1-102(21).

The attached resolution is requesting the City Council: (i) authorize the Police Chief in consultation with the Mayor or Chief Administrative Officer to: (i) put the items of property no longer needed as evidence or the proceeds from their sale to public interest uses in furtherance of West Jordan law enforcement or the general fund as they deem appropriate; and (ii) destroy any property that is unfit for a public interest use or for sale as they deem appropriate.

6 **A RESOLUTION AUTHORIZING THE POLICE CHIEF AND MAYOR OR**  
7 **CITY ADMINISTRATOR TO PUT UNCLAIMED PROPERTY NO LONGER**  
8 **NEEDED AS EVIDENCE TO A PUBLIC INTEREST USE**  
9

10 WHEREAS, in the regular course of business, the West Jordan Police Department takes custody  
11 of property that may be needed as evidence in a criminal proceeding; and

12  
13 WHEREAS, City Code § 3-1-19(B)(2) and Utah Code § 24-3-103 authorize the City of West  
14 Jordan ("City") to dispose of property being held as possible evidence for a criminal proceeding once it  
15 is no longer needed as evidence by putting it to a public interest use, putting the proceeds of its sale to a  
16 public interest use, or destroying the property if it is unsuitable for a public interest use or sale;

17  
18 WHEREAS, City Code § 3-1-19(B)(2) and Utah Code § 24-3-103 require the City to exercise  
19 due diligence in attempting to notify the rightful owner of the property that it is available to be returned  
20 before disposing of it; and

21  
22 WHEREAS, the West Jordan Police Department is currently in possession of property that was  
23 originally held as evidence, but is no longer needed as evidence; and

24  
25 WHEREAS, a list of the property that was originally held as evidence, but is no longer needed as  
26 evidence is attached to this Resolution as Exhibit A ("Property No Longer Needed as Evidence"); and

27  
28 WHEREAS, the West Jordan Police Department made reasonable and diligent efforts as required  
29 by law to notify the owners of the Property No Longer Needed as Evidence that it is available to be  
30 returned, including publishing notice in newspapers of general circulation; and

31  
32 WHEREAS, despite the City's reasonable and diligent efforts the Property No Longer Needed as  
33 Evidence remains unclaimed.

34  
35 NOW, THEREFORE, IT IS RESOLVED BY THE CITY COUNCIL OF WEST JORDAN, UTAH  
36 THAT:

37  
38 Section 1. The City Council authorizes the Police Chief in consultation with the Mayor or  
39 City Administrator to put the Property No Longer Needed as Evidence, or the  
40 proceeds from the sale of such property, to the public interest uses of law  
41 enforcement support or the General Fund as they deem appropriate.

42  
43 Section 2. The City Council authorizes the Police Chief in consultation with the Mayor or  
44 City Administrator to destroy any Property No Longer Needed as Evidence that is  
45 unfit for a public interest use or for sale as they deem appropriate.

47 Section 3. This Resolution shall take effect immediately upon passage.
