Original Proposed text: (found at lines 128-140 of Attachment 1 or Ordinance No. 21-06)

- D. At the council meeting described above:
- 1. The <u>acting</u> council chair shall, <u>in the following order and</u> in a manner materially similar to the following:
- a. Ask all the each council members present, one at a time, to declare if any of them ehoose he/she chooses to be considered (as a "candidate") or to not be considered (not be a candidate) for the position of council chair, by asking in alphabetical order by last name in odd-numbered years and in reverse alphabetical order by last name in even-numbered years;
- b. Ask all the council members to declare if they choose to be considered for the position of council chair;
- <u>b.e.</u> State that the declarations are closed and restate the names of those who are <u>declared</u> as candidates and those who are not candidates not declared, which shall include those affected by term limits and those who chose to not be considered;
- d. Restate the names of the other council members, all of whom are deemed to be declared ("candidates");

Proposed Amendment #1 text

- D. At the council meeting described above:
- 1. The <u>acting</u> council chair shall, <u>in the following order and</u> in a manner materially similar to the following:
- a. Ask all the council members to declare if any of them choose to not be considered for the position of council chair:
- <u>a.b.</u> Ask all the council members <u>present, at the same time,</u> to declare if they choose to be considered for the position of council chair;
- <u>b.e.</u> State that the declarations are closed and restate the names of those who are <u>declared</u> as candidates and those who are not candidates, and provide an opportunity for candidates to withdraw; and then restate the names of the candidates one more time not declared, which shall include those affected by term limits and those who chose to not be considered;
- d. Restate the names of the other council members, all of whom are deemed to be declared ("candidates");
