Announcements

- We received a report from Sysco Intermountain concerning a propylene glycol spill that occurred during the first week in January. There was a leaking drum in a containment room at the truck support facility. The antifreeze leaked between the cement floor and the wall to a location under the building. All appropriate agencies were notified and Enviro Care is under contract with Sysco to assess and address the situation.
- We discussed recent events that were reported to the health department such as
 possible human waste falling from an airplane. It has since been determined that
 birds were most likely the cause. In the unlikely event of waste from an airplane,
 it would be blue.
- A third incident occurred and was reported. Twenty gallons of diesel fuel was spilled as the result of a traffic accident at 7800 South and Mountain View Corridor. Salt Lake County Health is awaiting encroachment permits from the state to continue cleaned up of the roads right-of-way.
