- Jared Smith
  - o Self- introduction Risk Manager and Emergency Manager for the City.
  - Purpose of the LEPC meeting, mandated by the Federal Government is to coordinate private corporations with the emergency management for the City.
     One important element for the city is to help business owners come up with a
    continuity plan to insure business can stay afloat after a disaster.
  - State Program-Ready your Business- Checklist/Worksheet was distributed. https://www.utah.gov/beready/business/
- Paul Brockbank, WJ Fire Marshal
  - Introduced Lera Johnson, West Jordan Fire Department, who will be transcribing and distributing the minutes. Alisha Kimmerle has transferred to the Parks Department.
- Paul Crosbie, Salt Lake County Health Dept.
  - Partners in the community to make sure that incidents are cleaned up. If necessary chase down whomever did the discharge and have them pay to have it cleaned up and if necessary take legal action against them to pay fines, etc.
  - Recent Discharges:
    - Korean restaurant Grease interceptor never pumped in three years.
       Grease interceptors need to be cleaned out at least once a month.
       Whomever generates the wastes is responsible for the cleanup.
    - Texas Roadhouse, Taylorsville Dumping grease out the back door. Paid to clean it up. Now have a new plan in place.
    - Contractor dumping waste water from his tiling operation into the storm drain system. Storm drains are only made for storm water. Storm water goes straight to rivers, streams and lakes.
    - Emergency response number for the Health Department: 801-580-6681

- Tara Behunin, Utah Department of Emergency Management
  - o State Emergency Response Commission Oversees the statewide LEPC's
    - Per the guidance of the DEQ (Department of Environment Quality), some counties in the rural parts of Utah have the environmental response per the Health Department, which has the jurisdiction to enforce who can come and clean up and dispose of spills properly. Those counties who do not should be working to tie into the DEQ to have spills disposed of properly. Alleviating conflict for law enforcement officers to try and arrest those companies not qualified to dispose of spills properly.
    - Petroleum and Basic Hazmat Incidents Response Guidance Documents SERC is looking for feedback before documents become official.
    - Juab County Train derailment and spill will be probably be debriefed at the LEPC conference in October, 2019. Utilizing subject matter experts on how to take care of spills and do it safely
  - o Shake Out Drill April 18, 2019 (Statewide Earth Quake Drill)
    - At least once a year you should review with your businesses and homes what actions should be taken in an emergency situation. More information can be found at <a href="https://www.utah.gov/beready/">https://www.utah.gov/beready/</a>
