BACKGROUND

The last major update of the General Plan was completed in 2012. Over the last eight years, the City has undergone a number of substantial changes creating a need to update the General Plan and Future Land Use Map. There have been several minor revisions to the plan since 2012 but no comprehensive updates. City Council members have expressed an interest in re-evaluating and updating the General Plan and Future Land Use Map and have requested that a resolution be adopted to re-establish the General Plan Committee and appoint committee members.

**A RESOLUTION OF THE WEST JORDAN CITY COUNCIL
RE-ESTABLISHING THE GENERAL PLAN COMMITTEE**

WHEREAS, The West Jordan City General Plan and Future Land Use Map is now eight years old; and

WHEREAS, West Jordan City had substantial changes over the past eight years in land use and demographics; and

WHEREAS the West Jordan City Council anticipates further changes and that updating the General Plan and Future Land Use Map will assist in the future planning of the City; and

WHEREAS, The West Jordan City Council has the exclusive powers to establish the General Plan Committee under West Jordan Municipal Code § 1-6-13C (effective January 6, 2020) to appoint the General Plan Committee.

BE IT THEREFORE RESOLVED that the West Jordan City Council begin the appointment process for this committee. The committee shall be composed of an odd number of voting members not to exceed fifteen based on the number of applicants. One member of the Planning Commission shall be assigned by the Planning Commission to serve a one calendar year term as a nonvoting ex officio member of the General Plan Committee, who shall serve in addition to the other members of the General Plan Committee appointed by the City Council. One or more City Council members (not to exceed three) will be appointed as liaison to the General Plan Committee to assist in communication between the Council and the Committee.

BE IT FURTHER RESOLVED that the West Jordan City Council will appoint the General Plan Committee. The General Plan Committee will begin meeting as soon as practicable after being appointed.

BE IT FURTHER RESOLVED that at the direction of the City Council, the General Plan Committee will prepare updates to the general plan, which shall be submitted to the Planning Commission. In preparing its recommendations for updates to the general plan, including maps or elements, the General Plan Committee will review and propose land use map amendments and make recommendations to the Planning Commission and to the City Council; make reports and recommendations to the master transportation element, the moderate income housing element, and other elements of the general plan as directed by the City Council.
